GENERAL CONDITIONS OF SALE OF THE PRODUCT TIMGAD VOYAGES

TARIFFS

Our published prices are established according to the economic conditions in force at the time of the development of the Programs (July 2008). The variation of these economic conditions (in particular the cost of the transportation bound notably to the increase of fuel, royalties and taxes pertaining to the benefits offered as taxes of landing, embarking or landing, the amount of the airport taxes, the course of the mottos, etc.) can drag a revision of the prices without notice.

ANNULMENT

The annulment emanating the customer entails the remittance of variable expenses according to the nature of the journey and the date to which it intervenes:

- between 45 and 31 days before the departure, he/it will be kept 10% on the amount of the journey.
- between 30 and 21 days before the departure, he/it will be kept 30% on the amount of the journey.
- between 20 and 8 days before the departure, he/it will be kept 50% on the amount of the journey.
- between 7 and 12 days before the departure, he/it will be kept 75% on the amount of the journey.
- less than 2 days before the departure, he/it will be kept 90% on the amount of the journey.
- the day of the journey he/it will be kept 100% on the amount of the journey.

LODGING

According to the availabilities, the hotels, inns, lodgings, campings... mentioned in program, can be replaced by establishments of similar categories. The partial board generally consists of a dinner and a kid-lunch. The partial board or the complete pension doesn't take some account that the hotel benefits. Are excluded the meals that can be served on board of the planes.

AIDS - INSURANCES

The benefits TIMGAD Voyages presented here don't consist of guarantee Insurance, Annulment Luggage and Civil Responsibility. These insurances will be presented you by your agent TIMGAD Voyages on your demand.

OUR TARIFFS DON'T UNDERSTAND

- The expenses of delivery of passports, visas, expenses of vaccinations (on demand by your adviser TIMGAD Voyages)
- The expenses of lodgings, meal and transit, at the time of correspondence between 2 flights
- The taxes of obligatory airport, when they are not included in the amount of the aerial passage.
- The visits, spectacles, excursions...proposed in optional option.
- The exceptional expenses, consecutive to fortuitous events (strikes, bad atmospheric conditions...)

TAXES

The expenses of airport taxes can be modified under season and this until 30 days of the departure: the invoicing can vary therefore without notice. The amount of the cards of tourism and the expenses of visa is given for information only.

GUIDE DESTINATIONS

All information on the destinations are given for information only. The sanitary formalities and of police, are given for information only: he/it belongs to the traveler to insure that he/it is in order with the formalities of police, customs and health for his/her/its journey. The customers of foreign nationality must inquire by the consulate. A passenger who could not embark on one flight, to present the documents required, won't be able to pretend to any repayment.

LITIGATIONS

All relative complaint to one journey or to a stay must be formulated in writing and addressed by advisable fold, to the agency TIMGAD Voyages that have sold the forfeit, in the briefest delays and this at the latest, in the thirty days after the return of journey.
